# **Position on Abortion**

1. Based on the science establishing that the unborn child is a human being, the position of Louisiana Right to Life (LARTL) is that unborn children deserve equal protection under the law.

LARTL takes the position that when the mother's life is endangered, a physician may perform a medical procedure necessary in reasonable medical judgment to prevent the death or substantial risk of death due to a physical condition. However, a physician should make efforts to preserve both the life of the mother and the life of her unborn child in a manner consistent with reasonable medical practice under the circumstances.

Under what circumstances, if any, would you vote for abortion to be legal?

(a) Only to prevent the death of the mother (consistent with the LARTL position above).
