Sean Corcoran lost his first child, Michael, to abortion when he was 19 years old. In an effort to cope with the loss, Sean attempted to fill the emotional, psychological, and spiritual hole caused by the abortion with anything he could get his hands on. At 27, Sean was homeless, unemployed, in the midst of a full-blown 7-year addiction to methamphetamines, and dying alone on a bathroom floor. Through the grace of God, today Sean is an attorney, married to his lifelong crush, and the father to five more children, ages 7, 6, 3, 3, & 2, three of whom are adopted. Sean has noticed an absence in the abortion conversation of men who have had their children murdered in the womb, and is passionate about giving those fathers a voice and a sense of peace in their pain.

KIM HARDEY, MD

Dr. Kim Hardey is a 67 year old physician who graduated from Lafayette in 1976 and from LSU medical school in New Orleans in 1981. After completing his residency in obstetrics and gynecology he moved out of state for seven years, but moved to Lafayette in 1993 to start a pro-life practice. He has been on the board of the Womens Center of Lafayette for 20 years and has been a source of referral for abortion minded patients from the local crisis pregnancy center's for over 30 years.

JOE ZALOT, PH.D Staff Ethicist, National Catholic Bioethics Center

Dr. Zalot joined The National Catholic Bioethics Center as a staff ethicist in July 2017. He served from 2015 to 2017 as the regional director of ethics and spiritual care for Mercy Health–Cincinnati. He also served as a lecturer at the Athenaeum of Ohio/Mount St. Mary's Seminary, where he taught courses in medical ethics and

morality and justice in Catholic life. From 2004 to 2009, Dr. Zalot was an Associate Professor at Mount St. Joseph University in Cincinnati, and from 2009 to 2015 he was an Associate Professor (with tenure). At Mount St. Joseph, he taught courses in health care ethics, business ethics, sexual and reproductive ethics, introduction to Catholic theology, and marriage. Dr. Zalot earned a PhD from Marquette University in 2002, an MEd from Boston College in 1997, an MEd from Springfield College in 1991, and a BA from St. Anselm College in 1989. He has written two books and various articles and reviews, and he presents at academic conferences both domestically and internationally.
