#### **Background:**

The Louisiana State Legislature has approved a specialty license plate titled "Choose Life." The proceeds from the sale of this distinctive license plate will be distributed annually to qualified agencies. The funds will be distributed to non-governmental, not-for-profit, tax-exempt 501(c)(3) agencies or centers within the state of Louisiana. The services of these agencies or centers must include counseling and other services intended to meet the needs of expectant mothers considering adoption for their unborn children. Funds may not be distributed under any circumstances to any agency or center that is involved in or associated with abortion advocacy or activities, including, but not limited to, counseling for, or referrals to, abortion clinics, providing medical abortion-related procedures, or pro-abortion advertising.

Please note that as August 2022, Revised Statue 47:463.61.E.(3) now reads (we have bolded and underlined the important new phrase of the law):

"Organizations receiving monies under this Section shall use at least fifty percent of such funds to provide for the material needs of expectant mothers considering adoption for their unborn child **and for the material needs of expectant mothers considering parenting their children**, including clothing, housing, medical care, food, utilities, and transportation. Such monies may also be used to meet the needs of infants awaiting placement with adoptive parents. The remaining funds may be used for counseling, training, and providing pregnancy testing, but shall not be used for administrative, legal, or capital expenditures."

For the 2023 disbursement, agencies or centers that receive the funds <u>MUST DESIGNATE</u> fifty percent (50%) of the funds received to provide for the needs of women in a crisis pregnancy who are considering placing their <u>children for adoption</u> or <u>considering parenting</u>, including clothing, housing, medical care, counseling, food, utilities, and transportation. Such funds may also be expended on infants awaiting placement with adoptive

parents. The remaining fifty percent (50%) may be used for counseling, training, and providing pregnancy testing, but may NOT be used for administrative expenses, legal expenses, or capital expenditures.

To receive funds, each agency or center must enter and abide by a written application. In addition, each agency or center that receives these funds must submit an annual statement of the disposition of the funds to the Louisiana Right to Life Educational Committee to certify they were spent in accordance with this agreement.
